When are fire door inspections needed?

According to NFPA 80 Standards for Fire Doors and Other Opening Protectives:
Periodic inspections and testing shall be performed not less than annually.

New construction projects should have an initial inspection; for existing buildings, inspections should be a part of the annual preventative maintenance plan. Building owners and property managers are responsible for having these inspections completed, and ensuring that everything is in working condition. LaForce can make the process easier! Not only do we have experience working with healthcare buildings, assisted living facilities, educational occupancies, and other building types; we can help train and educate property managers on how to identify fire doors that might have the greatest potential for failure.

What do fire door inspections involve?

LaForce inspectors evaluate each opening, examining the frame, hinges, bolts, locks, exit hardware and any other items on each fire door to ensure proper functionality and compliance.

After the inspection is complete, a custom report is developed.

We offer four types of reports:

1. A simple field inspection report for each opening.
2. A standard LaForce inspection report that combines the per opening report with a summary of deficiencies and corrective actions.
3. A customized report specifically addressing what the building owner prefers. This could be a complete listing of items specific to an opening, including sizes and actual model numbers.
4. We can also input our findings directly into an owner's existing inspection or maintenance software. This gives some flexibility within their budget.

LaForce can provide a return trip to re-inspect openings that were originally found to be non-compliant. LaForce inspectors can also work with maintenance personnel on proper procedures to keep the fire doors up to code.
